BLENDED INTENSIVE PROGRAM (BIP) "ARCHITECTURE OF WAR" – fortification of XX century

International Workshop

1. INTRODUCTION

The University of Parma promotes participation in the **Blended Intensive Program (BIP)** entitled **"Architecture of War– fortification of XX century,"** organized as part of the Erasmus+ program and coordinated by **Gdańsk University of Technology – PL GDANSK02**, in collaboration with European partner universities. The workshop is part of a series of international educational activities dedicated to the theme of the reuse of military architecture.

3. TARGET AUDIENCE AND AVAILABLE PLACES

The call for applications is open to:

- Bachelor's and Master's degree students at the University of Parma. Minimum number of participating students:
- Minimum 5, maximum 8.

4. PROGRAM DATES AND STRUCTURE

- Virtual part (introduction and preparation): August 25, 2025 (other dates may be added)
- In-person part in Gdańsk (Poland): September 1–7, 2025

Total duration: 7 days in person + online component.

5. PROGRAM DESCRIPTION

The "Architecture of War" workshop concludes a series of international educational activities on the theme of bunkers and 20th-century European defensive architecture. Following previous stages in Portugal (2022), Italy (2023), and Slovenia (2024), the final stage in Gdańsk (Poland) will focus on design interventions in the historic area of **Westerplatte**, in collaboration with the **Museum of the Second World War**.

Students will be involved in:

- Design and field research activities in the area of fortifications.
- Study visits and documentation of military architecture.
- Interdisciplinary and international workshops.
- Online activities: readings, exercises, team preparation.

The program is linked to the European research project HORIZON MSCA-SE-2023 "HEPHAESTUS," with the active involvement of young researchers and doctoral students.

6. ECTS CREDITS

The program provides for the awarding of **3 CFU/ECTS** credits, subject to verification of active participation and submission of the required materials.

7. FUNDING

Selected students will receive an **Erasmus+ grant** to partially cover travel and accommodation expenses, in accordance with the current rules of the **KA131 program.**They will receive the contributions detailed on page 18 of the *"Bando unico per la Mobilità Europea e Internazionale A.A.2024/2025"*, available at the following link: <u>Bando unico SMS 2024-2025 DEF.pdf</u>.

The selection will be made by a Commission appointed by the Department of Engineering and Architecture according to the following criteria:

- Motivation and relevance to the course of study
- Academic merit
- Any previous international experience

12.PURPOSES AND METHODS OF DATA PROCESSING

The data provided are processed by the University of Parma, in its capacity as Data Controller, for institutional purposes, such as the performance of administrative, teaching and research activities.

The processing of data is necessary for the pursuit of its institutional purpose, pursuant to art. 6 of the European Regulation 679/2016 (hereinafter referred to as GDPR for brevity), and in compliance with the general principles of transparency, correctness and not excessive as per art. 11 of the Personal Data Protection Code DLgs 196/2003 (hereinafter referred to as the Code for brevity), as well as the principles laid down in Article 5 of the GDPR, with particular regard to lawfulness, the use of data for specific, explicit, legitimate purposes, in a manner relevant to the processing, accuracy, storage limitation, integrity and confidentiality, responsibility.

The data collected will be recorded, processed and stored for the time strictly necessary to achieve the purposes for which they were collected.

Personal data will be collected by the University of Parma and may be communicated for exclusively institutional purposes, and in line with the relevant legislative and regulatory provisions, to external parties such as CINECA, Er-GO, ALMA LAUREA and to external persons or companies acting on their behalf.

Data will be processed with the aid of electronic instruments; computer systems are equipped with measures to prevent the loss of data, unlawful or incorrect use and illegal access.

13.NATURE OF THE PROVISION OF DATA AND CONSEQUENCES OF ANY REFUSAL TO REPLY

The provision of data for the purposes referred to in the preceding point is indispensable for the fulfilment of the institutional purpose. Refusal to provide them will not allow the University of Parma to provide any services.

14. RIGHT OF ACCESS TO ACTS
